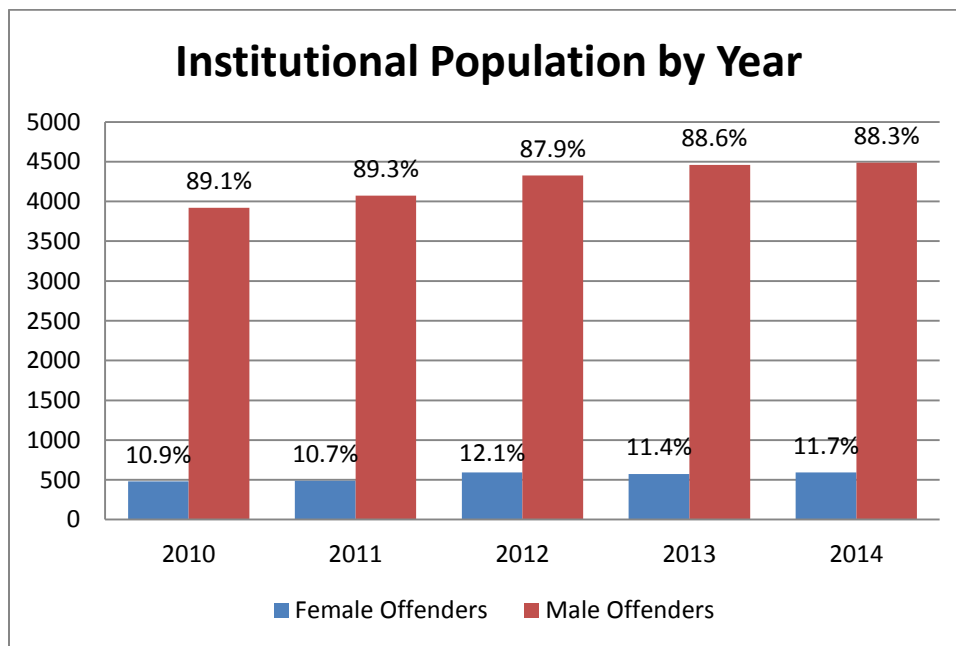

as of June 30 of the Reported Year

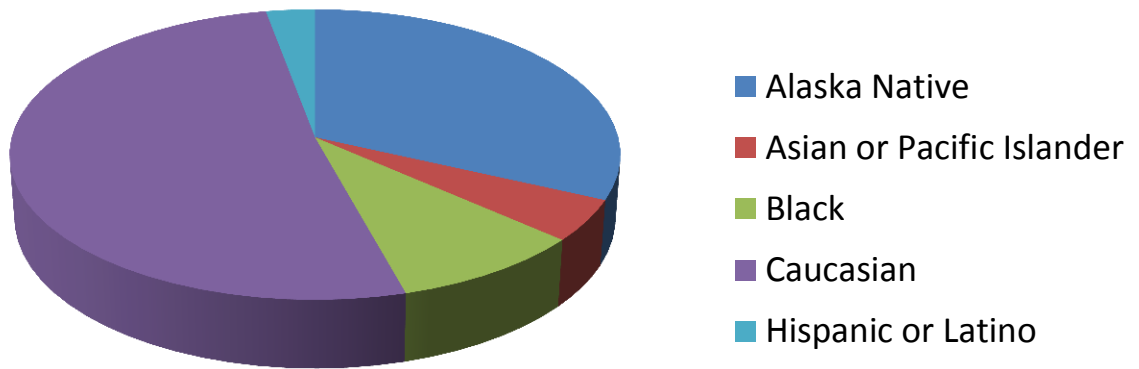

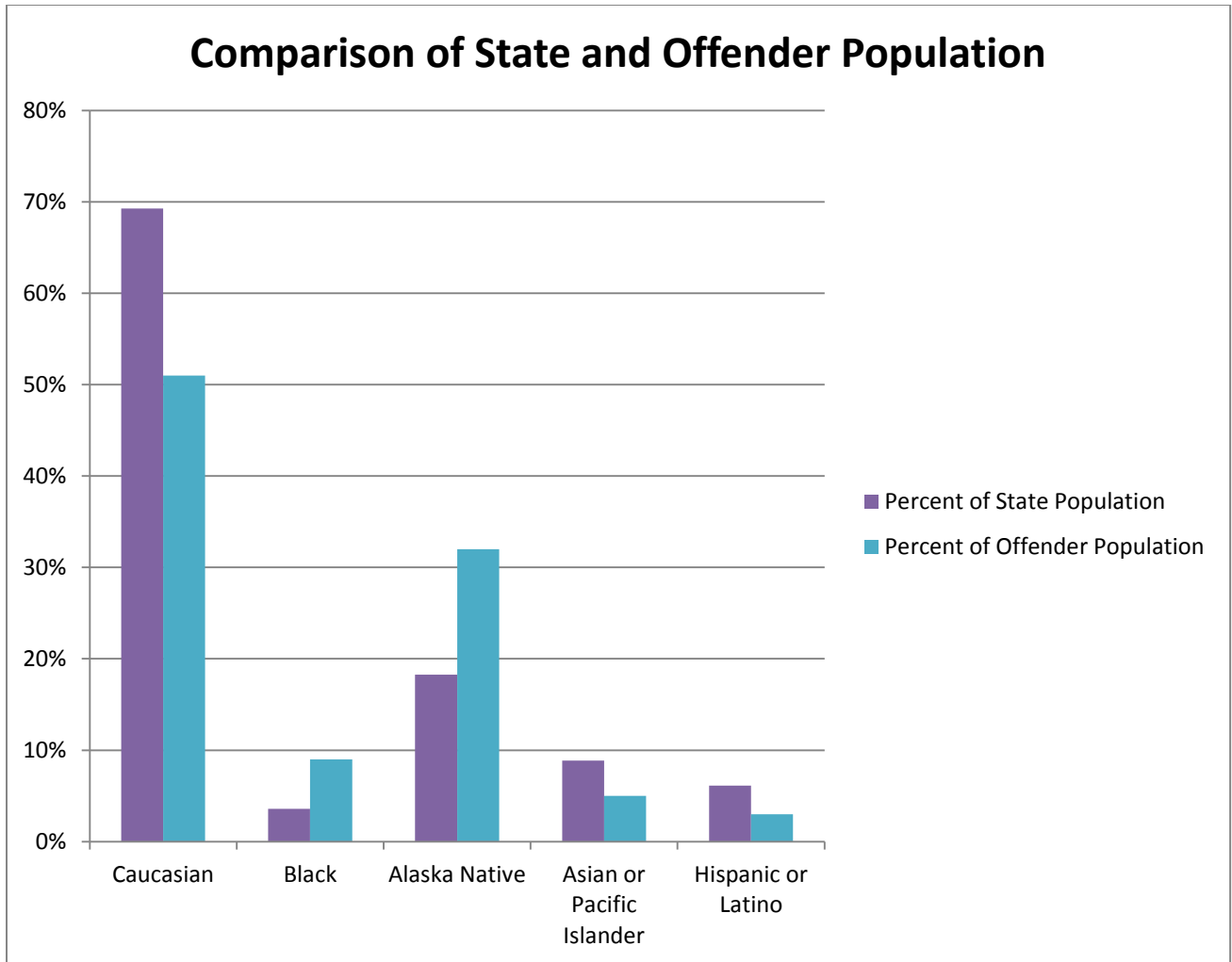

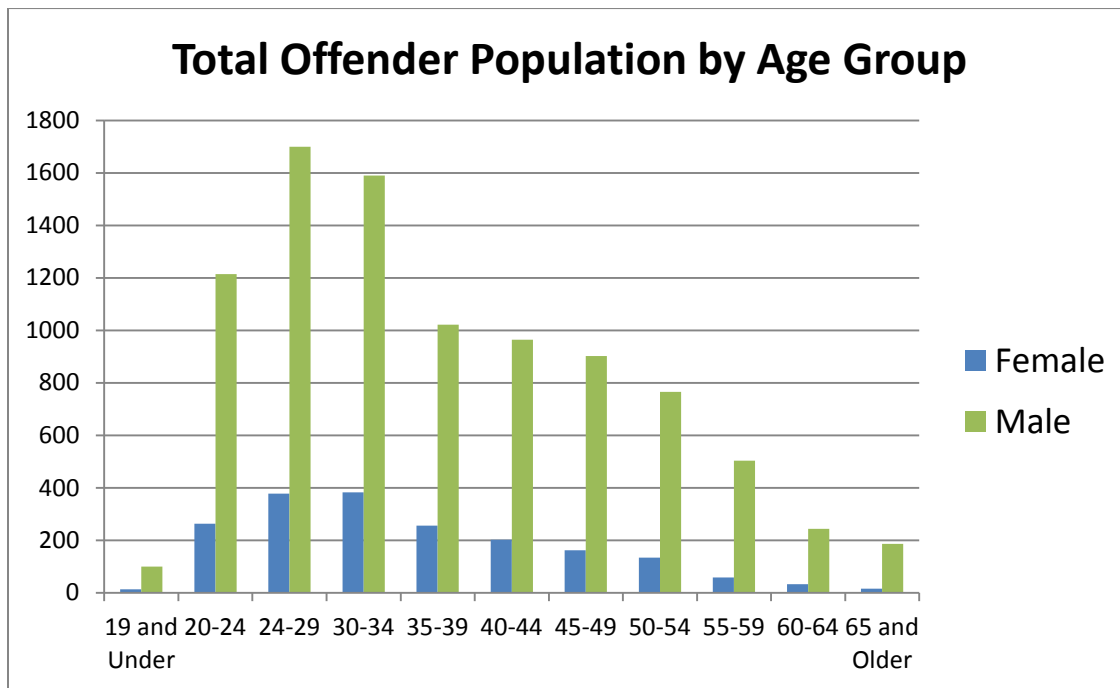
Total Offender Population by Ethnicity

2014 Alaska Correctional Institution Statistics

This chapter provides summary demographic data on offenders housed in Alaska's Institutional facilities.

The State of Alaska operates 12 correctional institutes throughout the state. This chapter is a snapshot of offenders incarcerated in Alaska and entered in the ACOMS database on June 30, 2014. Alaska's institutions are diverse and hold convicted offenders, non-criminal mental health holds, and individuals awaiting trial as well as a number of offenders held or convicted of federal crimes.

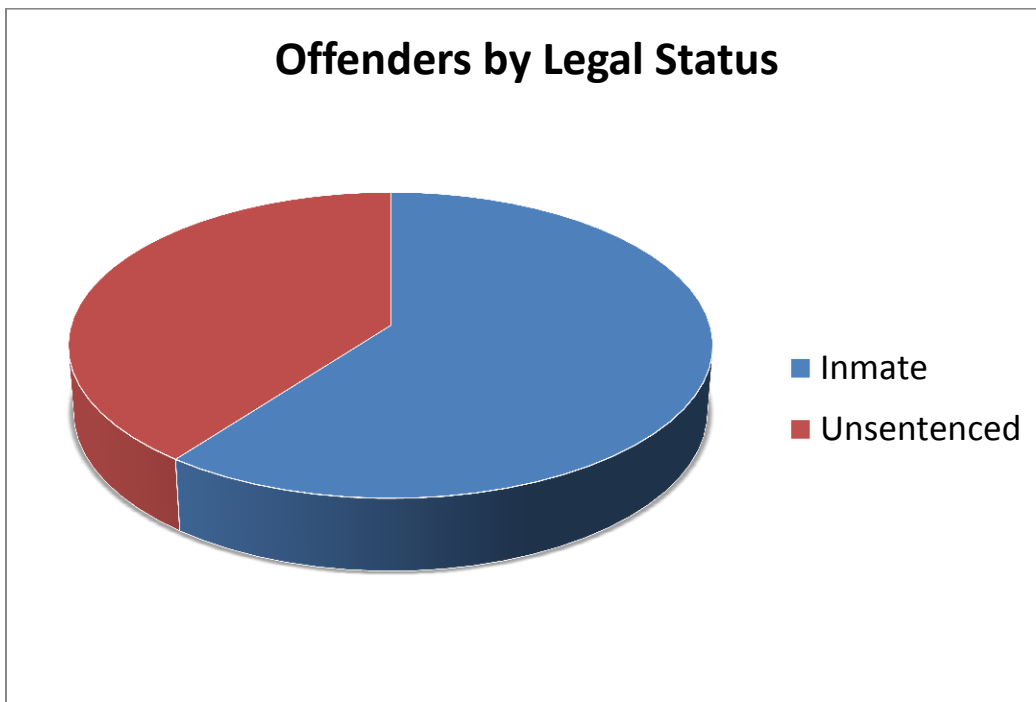

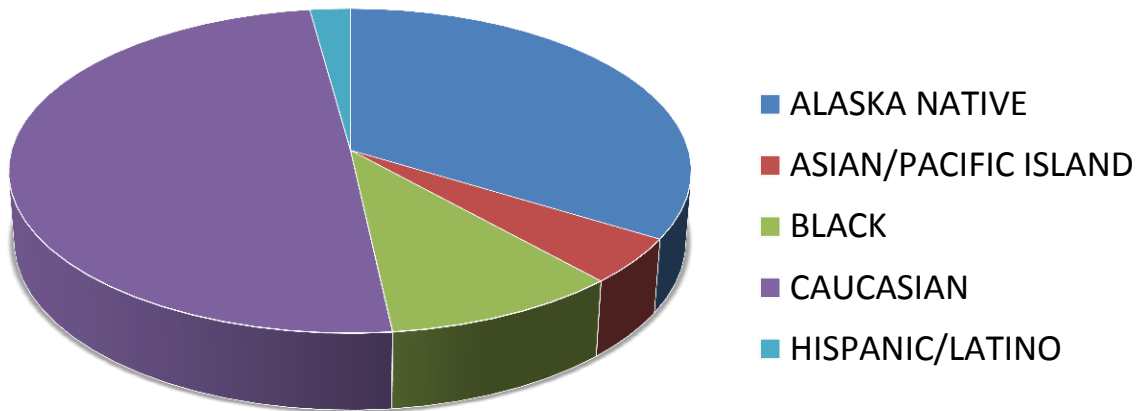

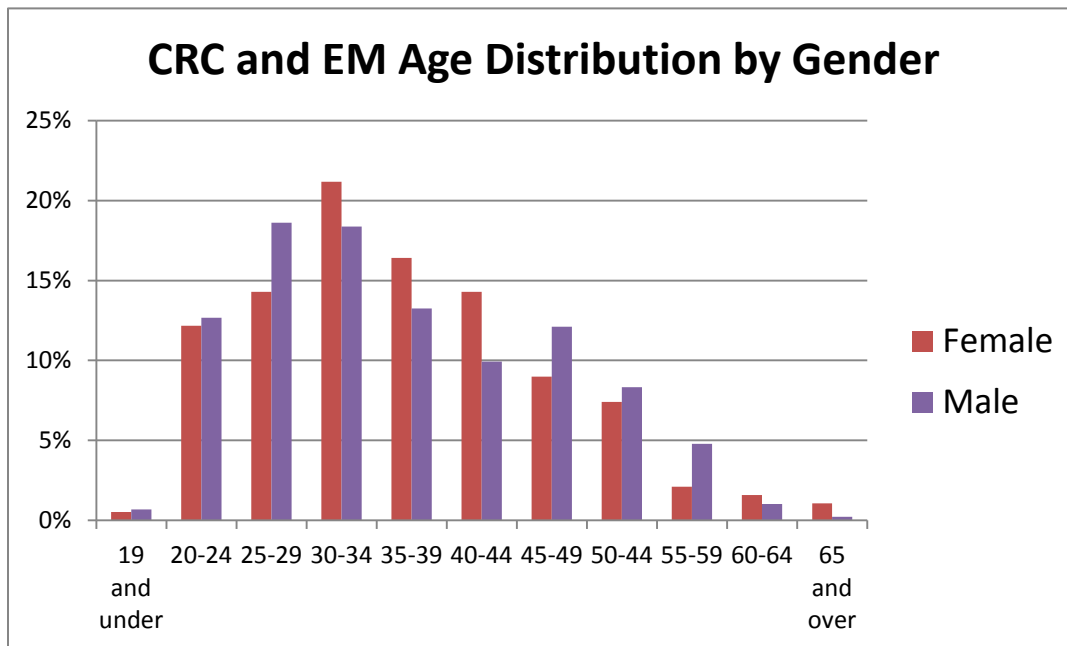

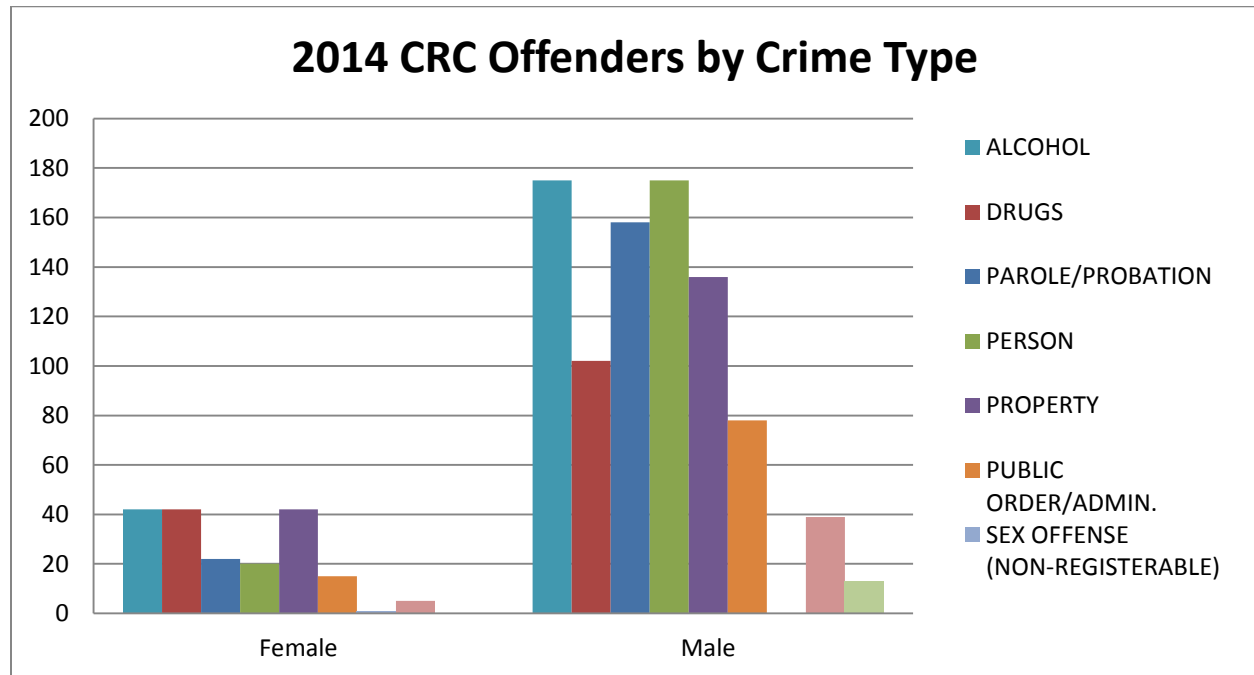

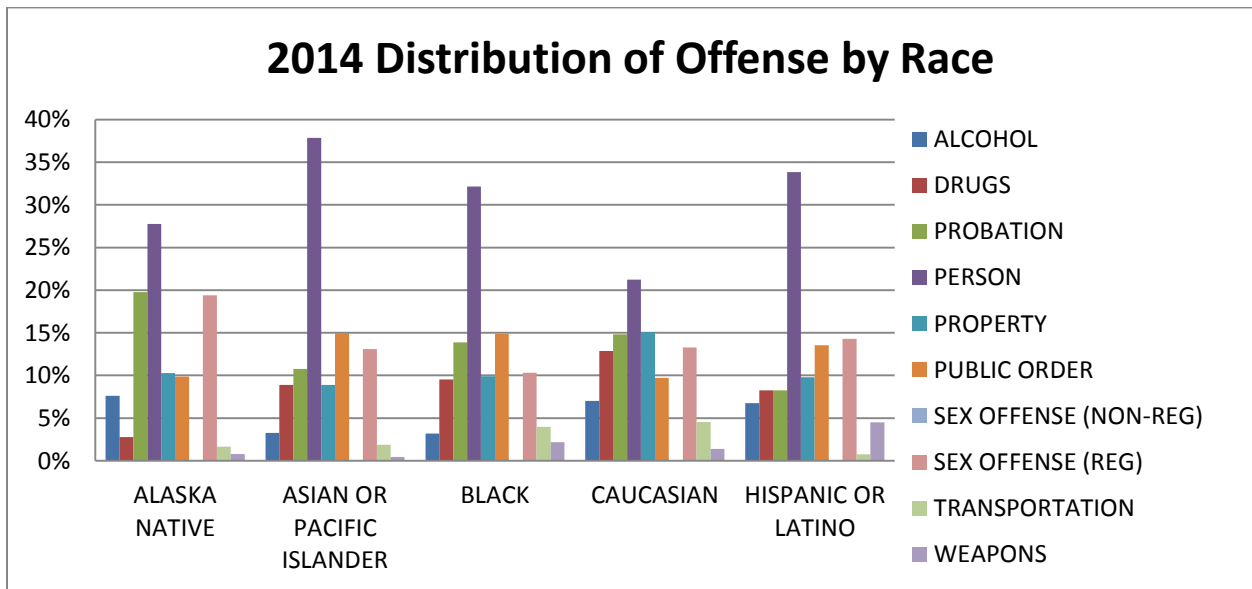

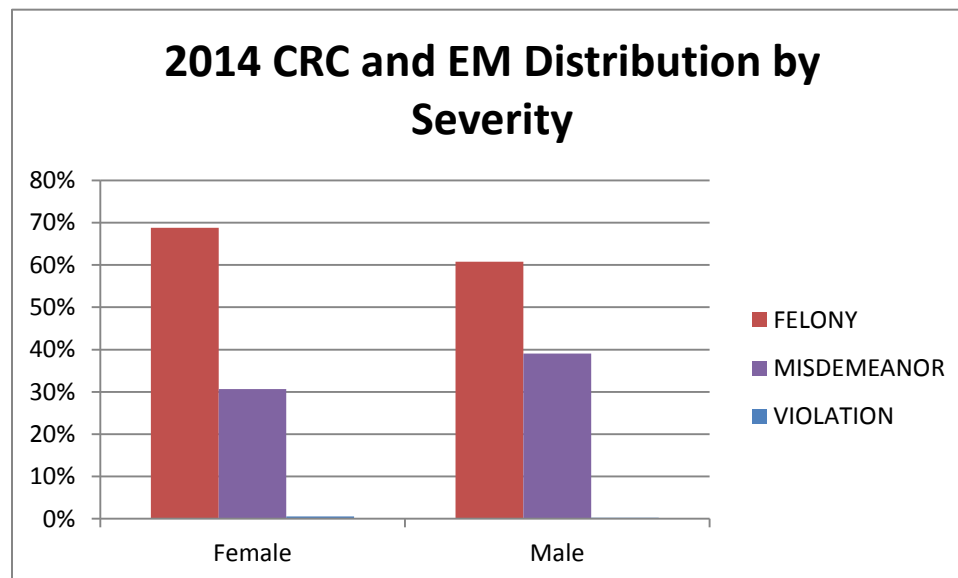
